Honorable Hector D. LaSalle

Presiding Justice of the
New York Supreme Court
Appellate Division,
Second Judicial Department



Honorable Hector D. LaSalle is the Presiding Justice of the Appellate Division, Second Judicial Department, appointed to by Governor Cuomo on May 25, 2021. Prior to his appointment as Presiding Justice, Justice LaSalle served as an Associate Justice of the Court from 2014 to 2021. Justice LaSalle served as an Associate Justice in the 9th and 10th Judicial Districts of the New York State Appellate Term from 2012 to 2014. From 2008 to 2014, Justice LaSalle also served as a Justice in the 10th Judicial District, Supreme Court.

From 2001 to 2008 and 1993 to 1998, Justice LaSalle worked in the Suffolk County District Attorney's Office as Deputy Bureau Chief of the Special Investigations Bureau, Head of Anti-Gang Unit, and an Assistant District Attorney. He served as Assistant Attorney General in the New York State Attorney General's Office from 1999 to 2001. Justice LaSalle was an Associate at Ruskin, Moscou, Faltischeck, P.C. from 1998 to 1999. Justice LaSalle received his B.A. in Political Science from the Pennsylvania State University and a J.D. from the University of Michigan Law School.

Sylvia Pastor Finklestein is an Assistant District Attorney and Director of the Office of Immigrant Affairs at the Nassau County District Attorney's Office.

Ms. Finklestein joined the Special Victims Bureau in 2001 and spent several years trying cases involving felony sex crimes and domestic violence. In 2007 she became Chief of the Child Abuse Unit and led the interdisciplinary team that investigated felony sexual crimes and assaults committed against children. She tried many cases where the victims were children under 13 years old, who had been subjected to severe physical and/or sexual abuse.

In January 2012, Ms. Finklestein was named Deputy Bureau Chief of the Narcotics & Gang Bureau and Chief of the Prescription Drug Unit. In 2015 she was promoted to Director of the Office of Immigrant Affairs.

In her current position, Ms. Finklestein coordinates the investigation and prosecution of crimes that target immigrants as victims and advises the District Attorney's Office and the community on matters where criminal law and immigration law intersect. She also develops and leads the Office of Immigrant Affairs' extensive outreach program and oversees the U-Visa and T-Visa certification process for the Nassau County District Attorney's Office. She chairs the Hispanic-Latino Advisory Council to the District Attorney and the Faith Leaders Council. On the DA's behalf, she is spearheading the Pathways Project, a gang prevention and support program for newly arrived immigrant students at the Hempstead Middle School and the Westbury Middle School.

Ms. Finklestein is a NYPTI (New York Prosecutors Training Institute) lecturer and is a member of the PINY (Protecting Immigrant New Yorkers) task force. She is a founding member of the New York State District Attorneys League for Immigrant Affairs (DALIA) and its past president.

Outgoing President's Message

Dear Family, Friends, Colleagues, Honorees and distinguished Guests,

Welcome and bienvenidos to our 20th Anniversary Scholarship Gala, in celebration of Hispanic Heritage Month. During this unique time, we are so appreciative to have you join us this evening as we celebrate the many accomplishments of the LIHBA. This evening we are honoring three remarkable community leaders: George Siberon, Executive Director of the Hempstead Hispanic Civic Association; Sylvia Finkelstein, Esq., Assistant District Attorney and Director of the Office of Immigrant Affairs at the Nassau County District Attorney's Office and Jacqueline Franco, NYS Certified Business Advisor at the Small Business Development Center at Stony Brook University. During a pandemic that disproportionately impacted the Latino community, these leaders continued to advocate for the Latino community and provided much needed resources and services. We are also delighted to recognize six deserving Latino law students who will receive an LIHBA Scholarship. Tonight, we also warmly welcome and are privileged to have the Honorable Hector D. LaSalle, Presiding Justice of the Appellate Division, Second Department, as this evening's keynote speaker.

When I took office, I had a goal to expand the reach of the LIHBA and to help nurture the interest, growth and development of our younger generation of lawyers. This year, the LIHBA created an LSAT prep course scholarship. The LSAT is a critical component of law school admission and is often a challenge for students of color. A student's success on the LSAT is the first step in helping them realize their dream of becoming a lawyer and diversifying our bar.

In my endeavor to help the LIHBA become a resource to law students and new lawyers, the LIHBA created professional development programs specific to law students and new lawyers. Many members of the LIHBA know first-hand the struggles of being the "first" in their family - the first to attend college, the first to attend law school, the first to become a lawyer. We hosted five virtual professional development programs that provided attendees a chance to engage with the panelists and have open discussions about their career paths and challenges they overcame.

We partnered and worked with the Franklin H. Williams Judicial Commission, Hispanic National Bar Association, Nassau Suffolk Law Services and Amistad Long Island Black Bar Association on presenting additional professional development programs and CLEs to our members. We hosted a Diversity and Inclusion CLE highlighting the history of our Afro-Latino brothers and sisters and our role in the racial justice movement.

The LIHBA continued to collaborate with the Nassau County Office of Hispanic Affairs with the Legal Information Program, under the guidance of our Past President, the Hon. Linda K. Mejias. This program connects LIHBA attorney volunteers to constituents looking to obtain free, accurate legal information. This year, the LIHBA recognized the need to provide legal information to a greater audience. With the assistance of our members, we hosted monthly “Know Your Rights” programs on Facebook Live in both English and Spanish, where legal topics important to the Latino community were presented, along with a Q&A segment.

The pandemic made the basic needs of our community a top priority. With a generous food donation from my law firm, Sullivan Papain Block McGrath Coffinas and Cannavo P.C. and our LIHBA members, we delivered food across Long Island- from Hempstead to Patchogue. We made sure our community partners, the Hempstead Hispanic Bar Association and Sepa Mujer, received large toy donations and supermarket gift cards to help put a holiday meal on the table. Our members and sponsoring firms generously donated hundreds of coats that we delivered to these organizations. We donated over fifty new coats and Target gift cards to Latina Sister’s Support Inc, a Suffolk County based cancer support group. Our charitable efforts were recognized several times this year by News 12 and Channel 7.

The pandemic did not stop the LIHBA from safely hosting our Prom Dress Drive, which started during the presidency of the Hon. Helen Voutsinas. We collected and brought over 150 gowns to Freeport High School where over 70 seniors said “yes” to the dress!

Many law firms that generally participate in the LIHBA summer internship program were affected by the pandemic and could not commit to hiring a summer intern. With the generous support of Bethpage Federal Credit Union, we created paid internships at the Nassau County Legal Aid Society, Sepa Mujer and a Judicial Internship. We were able to place an LIHBA intern with the Hon. Helen Voutsinas and continued to provide a paid summer internship at the Nassau County District Attorney’s Office as in past years.

The generosity of our sponsors and members ensures that the LIHBA is able to provide scholarships to deserving Latino law students. The competition for this year’s scholarships was intense. Our selected recipients are motivated, vibrant individuals who will undoubtedly make a difference in our profession and in our community.

This past year, the LIHBA joined forces with other Latino Bar Associations as we collectively called upon by the Governor to appoint more Latino Judges. We are proud of our efforts and the results, but there is more work to be done. We must continue to advocate to ensure that the judiciary is reflective of the rich diversity of our State, especially here on Long Island.

I am proud of the work accomplished this year. I want to thank the LIHBA Board for your steadfast commitment to our mission and goals and your unrelenting commitment to the Latino community. I want to thank the LIHBA members for trusting me to lead this Bar Association and your continued support. It has been my privilege to have served as president.

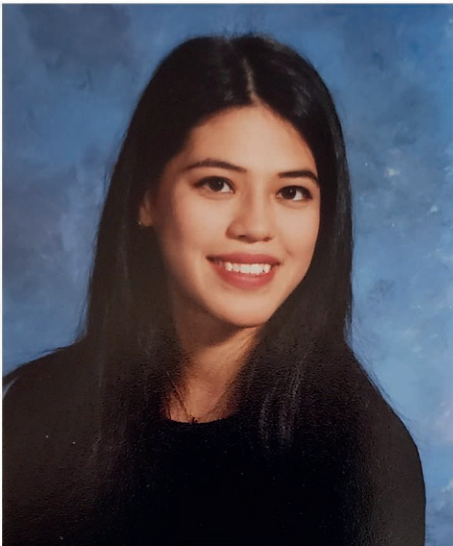

Deane School of Law at Hofstra University. I am a first-generation student, my parents immigrated to Long Island, and I was born here shortly after at the Nassau University Medical Center. We lived in Elmont until I was 10 years old, then moved out to Brentwood, Long Island where I graduated high school. My path to law school was full of hurdles. Some big hurdles, some small, some internal and some external. Without going into all the details and reasons, working class Latino communities like Brentwood, as many Long Islanders know, do not produce too many attorneys. Unfortunately, the neighborhood is known more for producing criminal law and immigration clients, which can become a hurdle for anyone growing up there. Although I wanted to be an attorney since I was in grade school, these hurdles slowed me down as my friends, family and myself became involved with the negative aspects of the community. However, the hurdles did not stop me and now I am very proud to be the first U.S. lawyer in my family, (after I pass the bar of course). Growing up in Brentwood was both a hurdle and an inspiration for me to attend law school. Although it slowed me down, it was seeing my friends and family members deal with the justice system which fueled a passion in me to help, and what better way to help than to become a counselor of law and a resource for communities like Brentwood. 
I would like very much to thank you for your sponsoring an LSAT prep course for two of our Pre-Law students.
